## Leasehold Improvement Depreciation, 179D, FIRPTA and EB-5 Extended

In late December, the President signed into law an omnibus appropriations bill which included permanent extension of the 15-year leasehold improvement depreciation period, which NAR actively advocated for. The bill also extended the 179D energy-efficient commercial buildings deduction for two years, and included reforms to FIRPTA which NAR has supported. Finally, the bill included a clean extension of the EB-5 Investor Visa Regional Center Pilot Program through September 30, 2016. 
