Uniform Fire Prevention and Building Code

The Department of State is developing a rule that will add provisions applicable to carbon monoxide detecting devices to the Uniform Fire Prevention and Building Code (Uniform Code). The rule will apply to all new and existing commercial buildings and restaurants that have appliances, devices or systems that may emit carbon monoxide, or that have an attached garage. These new provisions will be contained in a new Section 1228.4 to be added to 19 NYCRR Part 1228.

The Department of State will present the draft rule to the State Fire Prevention and Building

Code Council at its next meeting, which is now tentatively scheduled for May 15, 2015.

NYSAR Call for Action - Residential fire sprinkler mandate update

The State Fire Prevention and Building Code Council is meeting on May 15 to vote on pending building and construction code requirements for New York State. These proposed regulations may contain language requiring the installation of fire sprinkler systems in all new one– and two–family homes as well as townhomes. NYSAR believes education, transparency and consumer choice is the appropriate action versus another state mandate on purchasers of new homes in New York State. Take action and tell Gov. 
NAR at ICSC RECon 2015
